

## Official Rules

1. "The Danscompany of Gainesville", "Danscompany", or "DCOG" means the Danscompany of Gainesville whose principal place of business is: 5003 NW 34th Blvd STE 120 Gainesville, FL 32605.
2. The drawing shall consist of one or more prizes, each with a fair market value less than \$600 dollars. In the event the fair market value exceeds \$600 dollars, DCOG will issue IRS form 1099. The ticket holder shall place his or her raffle ticket(s) in the secure containers provided by DCOG which correspond to the prizes offered.
3. DCOG suggests a minimum donation of \$5.00 per raffle ticket. However, no purchase, payment, donation or contribution is required to participate in the drawing, and making a payment, donation or contribution will not increase your chances of winning.
4. The drawing will begin at 7 pm EST on February 27, 2016 and end before 9 pm EST on March 28, 2016.
5. The drawing will be held at Cameron Dancer Center 5003 NW 34 TERR, STE 120, Gainesville, FL 32605
6. It is the sole responsibility of the ticket holder to ensure the raffle ticket information is completely and legibly filled out with the following information:
  - (a) Legal name
  - (b) Full address to include zip code.
  - (c) Phone number including area code.
  - (d) Electronic address, i.e. email, or other form of electronic contact method if available.
  - (e) The designated prize the buyer has chosen if the raffle ticket is selected as the winner.
7. DCOG will not be responsible for any illegible, incomplete, misplaced, lost or stolen raffle ticket(s), or for any prize for which such raffle ticket(s) may have been tendered. If the ticket holder requests a DCOG member to place his or her raffle ticket(s) into a prize container without indicating which prize is preferred, the Danscompany of Gainesville reserves the right to place the raffle ticket(s) into the prize container which, in DCOG's sole discretion, represents the highest value prize.
8. DCOG will appoint a person to draw a winning raffle ticket for each prize, and a Judge to certify each winning raffle ticket and winner, subject to the rules above. The Judge's ruling as to the selection of winning tickets and winners shall be final.

The total number tickets printed will be 1600, and numbered sequentially: 1000-2599.
9. Odds of winning a prize are 1 out of 1600.
10. Odds of winning a specific prize are 1 out of the total number of raffle tickets deposited within each designated prize container.
11. Winning ticket holders need not be present to win.
12. All winners will be notified by mail via USPS and by electronic address (e.g. e-mail).
13. A list of winners will be provided upon written request, addressed to DCOG at its principal place of business.
14. The Danscompany of Gainesville reserves the right to limit the number of tickets acquired per individual, household or within a specific time frame prior to the start of the event.
  - (a) For the purpose of this drawing, the Danscompany of Gainesville reserves the right to limit the use of a raffle ticket to one (1) ticket every thirty (30) calendar days.
  - (b) For the purpose of this drawing, the Danscompany of Gainesville defines a household to include the related family members and all the unrelated people, if any, such as lodgers, foster children, wards, or employees who share the housing unit.
15. By participating in this fundraising raffle event, whether by making a donation, payment, contribution or tender of other consideration to DCOG, or whether acquiring and/or submitting a raffle ticket pursuant to these Rules, or whether by winning one or more raffle prizes, or whether by accepting and/or using a raffle prize (hereafter referred to as "raffle participant"), the raffle participant assumes, for themselves, their spouse, their children and other persons for whom they are legally responsible, any and all risks of loss, property damage, economic damage, personal injury and/or death, that may result therefrom. Furthermore, every raffle participant agrees, for themselves, their spouse, their children and other persons for whom they are legally responsible, to waive and release DCOG, its officers, directors, employees, members, agent and volunteers from any and all liability for all loss, property damages, economic damages, personal injury and/or death that may arise from participation in the raffle, and further agrees to defend, indemnify and hold harmless DCOG, its officers, directors, employees, members, agents and volunteers from any and all claims of liability for all loss, property damages, economic damages, personal injury and/or death that may arise from participation in the raffle.
